SAN DIEGO FACILITY

Pacific Research Network is a dedicated outpatient/inpatient research facility located in downtown San Diego. The clinic occupies 6,000 square feet, including six beds in private rooms for sleep studies, Phase I and migraine trials. Pacific Research Network maintains an on-site pharmacy, and an IATA and CLIA certified laboratory with -20 and -70 degree sample storage and is equipped with polysomnography and EEG capabilities. The site has a dedicated, controlled and secured outdoor smoking space. In addition, the site contracts with physicians for lumbar punctures/CSF sample taking storage, and has access to cardio and cardiopulmonary stress laboratories, and radiology facilities to perform X-ray, PETs (including AMYV ID), CTs and MRIs. Located just two miles from the San Diego International Airport, Pacific Research Network is easily accessible using public transportation.

RANCHO BERNARDO FACILITY

Pacific Research Network's Ranch Bernardo clinic is uniquely equipped to serve the predominantly elderly population 20 miles north of the main clinic. This site offers over 2,100 square feet complete with four private offices, two exam rooms, two sleep rooms, a CLIA-certified lab, an extended-stay subject lounge and ample parking. A large Common Room allows staff to host regular educational and outreach events to highlight studies, support groups and services.
